# Art . 1 Subject of the Call for Selection

It is opened a public competition based on examination of qualifications, exams and interview for the recruitment of one Researcher (permanent position) - III professional level, in **Systems Biology.** 

### Art. 2

# **Requirements for admission**

The participation in the selection is free, and open to all EU citizens.

To be eligible for selection must have the following requirements:

- a) EU citizenship. Family members of citizens of the EU member states can also apply, even without having the citizenship of in one of the EU Member State, as well as citizens of third countries holding residence in EU countries or permit for long-term residents, or having the refugee status or subsidiary protection status;
- b) Master Degree or equivalent Degree in Biological Sciences, or Marine Biology, or Environmental Sciences, or Marine Sciences or similar or equivalent degree.
- c) PhD in the field of call or consistent with the topic of the Call;
- d) to have no criminal convictions that prevent, in accordance with the current provisions, the establishment of an employment contract with Public Administrations in Italy;
- e) to be not dismissed or laid off from the public service;

- f) to possess all civil and political rights in the country of origin;
- g) regular position with regard to military service for Italian citizens who are subject to it.

Candidates are also requested to have:

- Competences in genomics, phylogenomics (computational genomics) and transcriptomics, for the study of biological networks related to gene regulation in complex systems applicable to the study of marine models;
- Knowledge and experience in evolutionary analysis with statistical and mathematical methods in the field of computational biology applied to biological systems with particular regard to the biology of marine organism development;
- Knowledge of advanced methodologies, experience and management skills enabling an interdisciplinary development of the research in the field of systems biology of marine organisms;
- The ISI scientific productivity normalized to the scientific experience ≥1 (calculated as the ratio of number of ISI publications and the number of years after the achievement of the PhD degree or from the date of the first publication if this is preceding the PhD title and/or in the last 3 years).

All requirements, under penalty of exclusion, must be fulfilled by the date of the deadline for the application and by the date of the employment.

Candidates in possession of the master degree achieved abroad must provide a declaration of equivalence to the Italian degree, released by Italian authorities. Candidates have the responsibility, under penalty of exclusion, to prove the equivalence by presenting the certificate of recognition, or alternatively the statement that the "request for equivalence" has been already requested and that the procedures for the evaluations are started.

Good knowledge of English and computer skills will be verified by the Examination Committee.

The candidates are admitted to the examination subject to verification of the possession of the admission requirements. The assessment by the

Administration or the Examination Committee of the lack of possession, even if only one of the aforementioned mandatory requisites will result in the exclusion from the selection or the loss of the right to the appointment.

#### Art. 3 Submission of applications - Terms and conditions

The application to the selection must be submitted exclusively through the following address:

where the candidates can select the present Call and obtain access to the online forms, upon registration to the system.

The application must be submitted no later than the thirty-first day following the date of publication of the Call in the Official Gazette of the Italian Republic - IV Special Series, at 1.00pm. This term, if falling in a festive day, shall be extended to the first day immediately after. The date of submission of the application is certified by the online system, which will be closed at the deadline, and will not allow the access to the procedure anymore.

For further information, or in case of any issues in submitting the application, the Candidates can contact the Responsible of the Procedure or the Support Staff by using the "Support Request" function.

In their application, the candidates must declare, under their own responsibility the following information:

- full name;
- date and place of birth;
- citizenship;
- if the candidate is an Italian citizen, the municipality where he/she is registered in the electoral lists or the reasons for non-registration or cancellation from such a list;
- non Italian candidates must declare to possess all civil and political rights in the country of origin (except for applicants holding refugee status or subsidiary protection status);
- to be exempt of criminal convictions and legal pending proceedings precluding the access to the position or indicate the convictions and pending prosecutions, and their specific content. Alternatively the declaration "nothing to declare" should be explicitly presented;
- Complete title of the Master Degree, including the date of achievement and the issuing Institute;
- Complete title of the PhD, consistent with the topic of the Call;

- The ISI scientific productivity normalized to the scientific experience ≥1 (calculated as the ratio of number of ISI publications and the number of years after the achievement of the PhD degree or from the date of the first publication if this is preceding the PhD title);
- In case the candidate has any handicap, this should be reported in the application form, stating what help is required in relation to the handicap and the possible necessity of extra time required (ex Art. 20 of the Italian Law 5 February 1992, n. 104);
- Good knowledge of the English language;
- Any services provided by public administrations and the causes of termination of employment;
- of not having been dismissed from the Public Administration for persistent poor performance, or not having been revoked by another employment for having produced fake or vitiated documents, or not been banned from public office, or not retired;
- previous or current employment in public Administrations, indicating the professional level and position;
- computer skills;
- possession of reserve or preference titles. The titles must be indicated in the application, otherwise they will be not evaluated;
- only for Italian candidates is requested the PEC (certified e-mail address) to be used for official notifications concerning the selection; foreign candidate should indicate their email address; all candidates should indicate also a valid telephone number.

After having completed the online procedure, the system will produce a declaration that the candidate is requested to print, sign, scan and save as a PDF file. This file must be uploaded in the system along with copy of the identity document (the system will require to upload both sides).

Candidates having the kit for digital signature can digitally sign the application.

After submitting the application, the candidate will receive an email confirming the submission. This message has the value of receipt. In case of need to reopen the application in order to be able to include any additions and / or changes within the deadline of the Call, the candidate can request the reopening of the application through the platform using the "Request support" function.

The reopening request must be presented online from Monday to Friday, 07:30am - 4:30pm GMT +1.

All communications concerning the Call will be sent to the e-mail address indicated by the candidates.

The Stazione Zoologica Anton Dohrn does not assume any responsibility for any failure to network connection, or in case of loss of communications due to incorrect or unclear transcription of personal data or addresses of the candidates or failure or late notification of change of address indicated in the application.

#### Art. 4 Exclusion from selection

Candidates are admitted to the selection on the basis of preliminary screening carried out by the Responsible of the Procedure.

Principles of exclusion:

- applications submitted in a different way from the online procedure reported above;

- applications not fulfilling the requirements listed in Article 2, comma a), b), c), d), e), f), g).

The General Director of the Stazione Zoologica Anton Dohrn may determine the exclusion of the candidate at any time when the lack of requirements has been certified by the Responsible of the Procedure.

A candidate will be excluded from all rights if reasons of exclusion are determined even after the completion of the selection.

False statements can be reported to the competent authorities.

#### Art. 5

## Presentation of titles

The application form must be attached to the *EuroPass* Curriculum Vitae (CV) in which the candidate will detail, in an analytical way, states, facts and personal skills, bringing the exact references and information for the evaluation of each title.

In particular, the candidate will have to indicate:

1. studies completed and qualifications;

- 2. the services provided, the role and functions performed, the positions held and their duration and the public or private Institutions where they have been undertaken;
- 3. any other scientific, technical, professional and educational activity, the functions performed, the positions held and their duration, the results achieved and the public or private Institutions where they have been undertaken;
- 4. PhD in the field of call or consistent with the topic of the Call;
- 5. the "Abilitazione Scientifica Nazionale" II level in the scientific disciplinary sectors BIO06, BIO10, BIO11, BIO18, BIO19 or similar related to the topic of the call the, is a priority criterium;
- 6. the complete list of the scientific production (journal papers, technical reports, monographs/books, book chapters) and technological production (national and international patents with information about their exploitation) in addition to:
  - a. total number of ISI publications with Impact Factor
  - b. total IF (based on the current data available from JCR);
  - c. H index
  - d. Total number of citations.
- 7. The list of publications indexed in the Core Collection of Web of Science, indicating, for each publication, the Accession Number.
- 8. The ISI scientific productivity normalized compared to the scientific seniority of the candidate:
  - a. Number of years after the achievement of the PhD degree;
  - b. Number of years after the first ISI publication;
  - c. Normalized scientific productivity (number of ISI publications with Impact Factor/years of scientific activity).

Concerning Comma 6, the candidates should indicate the date when the indices have been determined and the calculation method used (e.g., Scholar citations, Scopus or Web of Science).

The curriculum vitae must be completed and duly signed by the candidate with a legible signature. All declarations in the CV are considered as affidavits of certification and deed of notoriety according to art. 46 of Presidential Decree 445/2000.

The application must be accompanied by the publications of the candidate in .pdf format and all documents of affidavits of certification and deed of notoriety certifying all titles to be considered for evaluation.

For non-Italian candidates, the Curriculum Vitae must be accompanied by the declaration of equivalence to the Italian degree, released by Italian authorities, or alternatively the statement that the "request for equivalence"

has been already requested and that the procedures for the evaluations are started.

The affidavits of certification and deed of notoriety expected for Italian citizens are also fully applicable to the citizens of the European Union. Non-EU citizens resident in Italy may use affidavits of certification and deed of notoriety only for cases in which it is necessary to provide evidence, facts and personal qualities that can be certified or attested by Italian public or private subjects, or in cases where the production of the same declarations is given according to international agreements between Italy and the country of origin of the declarant.

Under Article 15 of the law 12.11.2011 n. 183 it is forbidden to show to public administrations and private providers of public services, certificates issued by the PA concerning states, facts and qualifications that are, therefore, increasingly replaced by the affidavits of certification and deed of notoriety (arts. 46 and 47 of Presidential Decree 445/2000).

The Stazione Zoologica, pursuant to Article 71 and in relation to the Articles n. 75 and 76 of the Presidential Decree 445/2000 and subsequent amendments, carries out control over the reliability of the affidavits.

### Art. 6

# **Examination Committee**

- 1. The Commission will be nominated by the Administration council of the Stazione Zoologica upon proposal of the President and their meetings <u>can</u> <u>be held by teleconference or videoconference</u>.
- 2. The Decree of nomination will be published of the webpage of the Stazione Zoologica Anton Dohrn at the following link:

- 3. In case of justified waiving or unavailability of one of the members, a deputy member is nominated, by Decree of the President of the Stazione Zoologica Anton Dohrn.
- 4. The members of the Examining Board are required to declare the absence of conflicts of interest which, in addition to legal obligations, is also extended to one or more of the following cases:
  - a. the Member of the Commission does not share professional or private interests with any candidate;
  - b. the member of the commission did not cooperate with a relevant part of the publications of any candidate;
- 5. Any changes in the legal status that occurred after the appointment do not affect the quality of the commissioner.
- 6. Any requests for rejection by one or more members of the Commission of selection by the candidates, if the conditions set forth in art. 51 of the

civil code of procedure, must be proposed to the President of the Stazione Zoologica Anton Dohrn within the peremptory term of fifteen days from the date of publication of the decree of appointment. After this deadline, requests for rejection by the commissioners are not admitted.

- 7. No later than forty-five days from the date of communication of the appointment, the Commission shall hold the first meeting, during which the criteria evaluation of qualifications and examinations, after issuing declarations of non-existence of incompatibility or conflict of interests pursuant to current legislation, are set.
- 8. The Commission concludes the Selection procedure within three months from the date of the written essays and the entire competition process cannot exceed 4 months from the appointment. The General Director, after consulting the President, with his own decree, may extend the aforementioned term for one time only and for not more than one month in case of objective impossibility on the part of one or more members of the committee.

Failure to comply within the deadline by the examining committee leads to the replacement of one or more members following an explanation of the reasons that led to the delay by the chairman of the examining commission. In this case, the President of the Stazione Zoologica Anton Dohrn provides with its own Decree to identify the new member(s).

# Art. 7

#### Qualifications

For the evaluation of the qualifications, the Commission has a total of 30 points. The qualifications evaluated are:

Curriculum Vitae et Studiorum	Max 10 points
Publications, scientometric indicators and patents	Max 20 points

The evaluation of the *Curriculum Vitae et Studiorum* will essentially be aimed at highlighting the experience of the candidates, at understanding their real scientific experience and the capability to perform researches and promote scientific activities related to the topic of the call.

The evaluation of the *Curriculum Vitae et Studiorum* will essentially be aimed fostering the competitiveness of the Italian research system at international level, and the merit criteria for the selection of the candidates will be determined by giving priority to:

- The proven quality of the scientific productivity;

- PhD in the field of the present Selection or consistent with the topic of the Call achieved by no more than 5 years or proven equivalent experience

and technological competence by no more than 8 years from the Master Degree;

- National and international awards and recognitions;

- Scientific coordination and/or participation in national and international research projects;

- At least 3-years experience in research centres, national and international institutions, either public or private

In addition, the Commission will evaluate the following aspects of the candidates' CV:

- *a*) ability to attract funds from national and international competitive calls (e.g., national and international research projects, third party contracts), highlighting the positions held and any responsibilities assumed and their relevance;
- b) scientific coordination and/or participation in national and international research projects related to the topic of the call with particular attention to EU projects;
- c) networking skills and participation in scientific societies;
- *d*) participation in editorial committees of scientific journals;
- *e*) field experiences and specific national and international competences related to the topic of the call;
- f) national and international award for research activities;
- *g)* training activities, including tutoring of master's degree / specialization or doctoral thesis;
- *h*) third mission activities (technology transfer, patents, public engagement, etc.).

The evaluation of each title related to the above list is carried out considering specifically the significance that it assumes in relation to the specific role of the candidate and the quality and quantity of the research activity carried out by the single candidate and in relation to the topic of the call.

The evaluation must consider especially the degree of independence acquired by the candidate with respect to the research groups within which his initial training was held and his ability to work independently.

It is preferential to have performed at least one year (including noncontinuative or post-doctoral research) of research activities abroad at universities and / or internationally recognized foreign research centers.

The "Abilitazione Scientifica Nazionale" - II level is a priority criterium.

The evaluation of publications, scientometric indicators and patents will be aimed at highlighting the candidates' aptitude, proven by objective elements,

to determine significant progress in the research area covered by the present selection, and will include:

- a) Consistency of the activity of the candidate with the topic of the Call or with the related interdisciplinary topics (publications not pertinent to the topic of the Call must be excluded from any evaluation);
- b) Scientometric values (referred exclusively to the publications related to the topic of the Call) to determine the scientific relevance of the editorial placing of the publications and their spread within the scientific community, with particular reference to the average IF of the publications, to the placing of the journals in the quartiles of the reference areas;
- c) originality and innovation of the scientific production and methodological strictness;
- d) individual contribution of the candidate, analytically determined in the papers in collaboration.

To facilitate young researchers and promote their recruitment, all titles (as for the scientometric data) will be evaluated taking into consideration the productivity of the candidates (i.e. they will be normalized with respect to the experience as number of years starting from the doctoral thesis or from the date of first publication of the candidate).

For the evaluation of the candidates the examining commission has to take into account the fact that the criteria listed above have been defined in accordance with Ministerial Decree 163/2018 Article 1, paragraph 4.

Before examining the documentation presented by the candidates, the examining commission will determine the criteria for the division of the maximum scores attributed to each category of qualifications.

The qualifications must be available by the deadline of the call.

The evaluation of the qualifications will be carried out after the written essays, only to the candidates who have sustained them.

# Art. 8 Examinations

1. The exams are divided into:

a) two written tests in Italian or English, chosen by the candidate, the first with a theoretical content and the second with a more applied approach, aimed at ascertaining the possession of skills consistent with the scientific activity indicated in the Call;

b) an interview, in Italian or English, chosen by the candidate, consisting in the discussion of written tests, curricular experiences and publications.

The interview is also aimed at ascertaining the knowledge of English and computer skills.

For the evaluation of the examination, the Commission has the following points:

- 20 points for the first written examination
- 20 points for the second written examination
- 20 points for the interview.
- 2. The day(s), place and time of the written examinations, when not defined in the calls, will be communicated to candidates with at least with a fifteen-days notice prior the date of the examinations. The diary of the exams is also published on the institutional website of the Anton Dohrn Zoological Station at:

http://www.szn.it/index.php/en/tenders-and-job-opportunities/jobcalls.

- 3. The written examination and the practical/theoretical examinations can be carried out in the same day, if the total time limit of six hours is not exceeded, with the exclusion of additional technical times.
- 4. To pass the threshold and being admitted to the interview, the candidates must obtain at least 14 over 20 points in each of the two written examinations and at least 21 over 30 points in the evaluation of qualifications.
- The notice convening the interview, if not defined in the Call, is given at least twenty days before the date of the interview.
  Candidates admitted to the interview are informed of: a) the results obtained in the two written examination and in the evaluation of qualifications; b) location, date and time of the interview.
- 6. At the end of the interview, the Commission draws up the list of the candidates examined with the indication of the marks reported. The list, signed by the President and the Secretary of the Commission, is posted in the same day at the official board of the Stazione Zoologica Anton Dohrn.
- 7. To pass the threshold of the interview, the candidate must obtain a minimum score of 14 over 20 points and at least sufficient judgment concerning English and informatics.
- 8. Candidates with need for assistance during the examination in relation to the specific disability, must indicate this need in the application form.
- 9. To be admitted to the examination tests the candidates must present a valid identification document. Candidates absent at the exam tests on the set dates will forfeit their right to participation.

- 10. At the end of the examinations, the Commission draws up the ranking of merit and indicates the winner, in the person of the candidate who has obtained the highest final score given by the sum of the scores obtained in the evaluation of qualifications and in the individual exams.
- 11. Pursuant to Legislative Decree 25 May 2017, n. 75 only one candidate is admitted in the ranking for calls containing up to 5 positions with the same profile.

# Art. 9

### **Reserve or preference titles**

- In case of equal merit of two or more candidates who have passed the interview and who intend to assert reserve and / or preference titles, expressly indicated in the application, among those provided for by art. 5 of Presidential Decree 487/94, must send to the Responsible of the procedure, referred to in art. 14 of the Call, to the PEC address: <u>rupconcorsi@legalmail.it</u>, within the peremptory term of fifteen days, starting from the day after the interview, substitutive declarations of certification or of the deed of notoriety pursuant to Articles. 46 and 47 of the D.P.R. 445/2000, certifying the possession of the aforementioned qualifications on the date of expiry of the deadline for the submission of the application for participation in the competition.
- 2. Candidates not resident in Italy may send the aforementioned documentation to the e-mail address recruitment@szn.it.

#### Art. 10

# Legality of the acts Approval of the ranking and nomination of the winner

- 1. The General Director, within thirty days after reception of the documents by the Commission, after verification of the regularity of the procedure, approves the order of merit with his own provision and nominates the winner.
- 2. In case of equal merit of two or more candidates, the set of criteria of preference defined in Art. 5 of the Decree of the President of the Italian Republic, May 9, 1994, n. 487, will be applied.
- 3. In case of procedural irregularities, the documents are returned to the Commission, setting a deadline.
- 4. The provision referred to in paragraph 1 is published on the website at the address <u>http://www.szn.it/index.php/en/tenders-and-job-opportunities/job-calls</u>, and the publication will be notified through the Official Gazette of the Italian Republic.

# Art. 11 Recruitment

- 1. The winner of the selection will be recruited with permanent contract of Researcher - III professional level, and will receive the remuneration set in the National Collective Labour Agreement for Research and Experimentation Institutes.
- 2. The winner of the selection, who does not start the service within the prescribed time, if not differently agreed or unless prevented from so doing, loses the right to the recruitment.
- 3. The winner of the selection will have to present, in means and time set by the Office of Human Resources, the documents requested with the letter of recruitment.
- 4. Based on the provisions of art. 55 quater of the Legislative Decree n. 165/2001 and subsequent amendments and additions, in the case of documentary or declarative falsifications committed for the purposes or at the time of the establishment of the employment, the disciplinary sanction of dismissal without notice is applied.

# Art. 12

# Privacy policy

- 1. According to the General Data Protection Regulation (GDPR) n. 679/2016 and the legislative decree, May 18 2018, n. 51, the personal data provided by the candidates will be collected only for the selection purposes and subsequent recruitment.
- 2. The release of such data is mandatory for the evaluation of the participation requirements, the lack of it may determine the exclusion from the selection.
- 3. The candidate is entitled to the rights including the access to his/her data as well as some complementary rights including the right to have rectified, updated, completed or deleted any wrong or incomplete data, or data obtained in a way non complying with the law in force, as well as the right to object to the data treatment based on legitimate reasons.
- 4. The candidate can invoke his/her rights against the Stazione Zoologica Anton Dohrn addressing the claim to the Data Controller.

# Art. 13
